Recognition of Certified GreenRE Manager

To encourage recognition and involvement of these green professionals, projects with one principal member that is a certified GreenRE Manager can earn GreenRE credits if they are an active member in the project team. Please refer to the respective GreenRE criteria for the scoring methodology.

Maintaining Certification for Certified GreenRE Manager

In order to maintain the high standards of professional competency, the validity period of the certified GreenRE Manager will be granted on a 3-yearly basis. For renewal (2 years for every renewal application), the applicant is required;

- i. to attend a GreenRE Refresher Course or Part 1 of GreenRE Manager's Course,
- ii. to complete at the point of renewal of application (Note: completion means that the Letter of Award, stating the GreenRE rating for the project, has already been awarded by GreenRE Sdn Bhd. It does not mean the physical completion of the project):
 - 1. **ONE** GreenRE **GOLD** or **PLATINUM** project (Existing or New) + **10** GreenRE CPD points or green courses approved by the Management of GreenRE OR,
 - 2. **ONE** GreenRE <u>SILVER or BRONZE</u> project (Existing or New) + **15** GreenRE CPD points or green courses approved by the Management of GreenRE OR,
 - 3. **20** GreenRE CPD points or green courses approved by the Management of GreenRE (for academician or non-practicing GreenRE Manager).
